1. The intending participants are requested visit our web site [www.adanipower.com](http://www.adanipower.com) and read the instructions & procedure explained under the "Tenders" section. For any further clarification/queries, please contact us on Telephone: (079) 25557400 Telefax: (079) 25557177.
2. ONLY Registered Participants are allowed to participate and bid at our Live-Auction Online. To become Registered Participant, you are required to fill-up the Form (Annexure –A) available on our said website. Please read instructions carefully.
3. All those who have dully filled the online Registration Form and wish to participate in the auction, should send their Caution Money Deposit (CMD) by DD of nationalized bank favoring '**Adani Power Limited**' payable at **Ahmedabad** along with details in the Registration Form attached herewith through courier or personally and obtain necessary receipt for the same. CMD must reach the **Seller (Adani Power Limited)** on or before 17:00 hours of **16-04-2013**.

Forms received on the day of e-Auction for becoming Registered Participants may not be allowed to participate at the Live-Auction and their DD will be returned to them through Courier at his/their risks. Hence, in your own interest, you are requested to complete all the formalities to become Registered Participant in advance and well in time.

4. Refundable CMD @ 5% shall be paid in advance for participating at our eAuction. EMD should be paid by DD/RTGS favoring **Adani Power Limited**, payable at **Ahmedabad**.
5. **Please note the DD against EMD must be sent to the Seller in advance along with Registration Form attached herewith on or before 17-00 PM, on 26-03-2013. The Seller is not liable for the delay or late receipt of DD whether sent through Courier or Post.**
6. All the Bidders who have submitted the requested CMD and completed Registration Process shall be provided User ID and Password to participate in the e-Auction by Seller.
6. Please do not reveal / pass your User ID and Password to any other person/s. It is your personal property and we will not be responsible for any leakage or misuse or illegal use of your User ID and Password. Nevertheless, you will be held personally liable to the Seller for any misuse or illegal use of your User ID and password by other person/s and any successful transaction online by such unauthorized person due to your negligence will be considered as your own transaction and you will be required to fulfill the Contract as per terms and conditions of the sale.
7. Once you login, you cannot use the same username and password to login from another machine before logging out from the previous one.
8. For your perusal, an Online Auction DEMO/Mock Auction shall be available only for Registered Participants/ Members to practice and get acquainted with the system one day prior to the Live Auction. **Nevertheless, if you wish to learn thoroughly in person, we can train your representative by prior appointment, PROVIDED you have paid CMD in advance.**
9. Caution Money Deposit of unsuccessful participants or balance CMD will be returned to them through Courier within 20 working days following the date of Live-Auction Sale on receipt of Form "B" attached herewith.
10. Taxes & Duties mentioned in the catalogue are only indication and Actual rate in force at the time of delivery will be charged.

11. In all the above sales, the sale will get automatically extend for 5 minutes ONLY IF THERE IS A BID IN LAST 5 MINUTES OF SCHEDULE END TIME. For Example, Lot No. 1 Starts at 11:00 a.m. & Ends at 11:20 a.m. then, **ONLY IF THERE IS A BID/S BETWEEN THE TIME 11:15:01 AND 11:19:59, THE LOT WILL EXTEND FOR 5 MINUTES, OTHERWISE IT WILL BE CLOSED DOWN.** Please note, even if there are five bids within extended period of five minutes, the extension will ONLY be for 5 minutes and not more. The extensions will automatically be continued till somebody bids within five minutes.
